Hans Ulrich Meister was CEO of the Switzerland Region at Credit Suisse from 2008. From 2011 he was also CEO of the Private Banking Division and from 2012 Head of the Private Banking & Wealth Management Division, responsible for the private banking business in EMEA (Europe, Middle East, Africa) and Asia Pacific. In these roles he was also a Member of the Executive Boards of Credit Suisse Group AG and Credit Suisse AG. Before being appointed CEO of Credit Suisse Switzerland, Hans-Ulrich Meister worked for UBS for more than 20 years, most recently (from 2005 to 2007) as Head of

Private & Business Banking for UBS in Switzerland and as a member of the UBS Group Managing Board. Prior to that, he was responsible for the Large Corporates & Multinationals business area. In 2002, Mr. Meister worked for Wealth Management USA at UBS in New York. Hans-Ulrich Meister is a graduate of the University of Applied Sciences in Business Administration Zurich. He has also completed Advanced Management Programs at the Wharton School and Harvard Business School.
